#### **INTENDED USE**

Hardy Diagnostics CRITERION<sup>TM</sup> Sabouraud Dextrose Broth is recommended for the isolation, cultivation, and maintenance fungi and yeasts.

This dehydrated culture medium is a raw material intended to be used in the making of prepared media products, which will require further processing, additional ingredients, or supplements.

#### **SUMMARY**

Sabouraud Dextrose Medium was formulated by Sabouraud in 1892, for culturing dermatophytes.<sup>(13)</sup> The pH is adjusted to approximately 5.6 in order to enhance the growth of fungi, especially dermatophytes, and to slightly inhibit bacterial growth in clinical specimens.<sup>(2)</sup> Chloramphenicol may be added as a broad spectrum antimicrobial, to inhibit growth of a wide range of gram-positive and gram-negative bacteria.

CRITERION<sup>TM</sup> Sabouraud Dextrose Broth contains peptones which provide a source of amino acids and nitrogenous compounds for the growth of fungi and yeasts. Dextrose is added as the energy and carbon source.

### **FORMULA**

Gram weight per liter:	30.0gm/L
Pancreatic Digest of Casein	5.0gm
Peptic Digest of Animal Tissue	5.0gm
Dextrose	20.0gm

Final pH 5.6 +/- 0.2 at 25°C.

#### STORAGE AND SHELF LIFE

Store the sealed bottle(s) containing dehydrated culture medium at 2-30°C. Dehydrated culture medium is very hygroscopic. Keep lid tightly sealed. Protect dehydrated culture media from moisture and light. The dehydrated culture media should be discarded if it is not free-flowing or if the color has changed from its original off white.

Store the prepared culture medium at 2-30°C.

The expiration date on the product label applies to the product in its intact packaging when stored as directed. The product may be used and tested up to the expiration date on the product label and incubated for the recommended incubation times as stated below.

#### **PRECAUTIONS**

This product may contain components of animal origin. Certified knowledge of the origin and/or sanitary state of the animals does not guarantee the absence of transmissible pathogenic agents. #### METHOD OF PREPARATION FOR DEHYDRATED CULTURE MEDIA

- 1. Suspend 30.45gm of the dehydrated culture media in 1 liter of distilled or deionized water.
- 2. Heat to boiling and mix to dissolve completely.
- 3. Sterilize in the autoclave at 121°C. for 15 minutes.

#### PROCEDURE AND INTERPRETATION OF RESULTS

#### **LIMITATIONS**

It is recommended that biochemical, immunological, molecular, or mass spectrometry testing be performed on colonies from pure culture for complete identification.

Some formulations may require a settling period before pH testing of the prepared medium. If the pH is tested immediately after preparation and is out of specification, retest the medium after 24 hours to obtain final pH results. Always take pH reading at room temperature.

A non-selective and selective medium should be inoculated for isolation of fungi from potentially contaminated

specimens.

#### MATERIALS REQUIRED BUT NOT PROVIDED

Standard microbiological supplies and equipment such as autoclaves, incinerators, and incubators, etc., are not provided.

#### **QUALITY CONTROL**

Hardy Diagnostics tests each lot of commercially manufactured media using appropriate quality control microorganisms and quality specifications as outlined on the Certificate of Analysis (CofA) and the CLSI document M22-A3 *Quality Assurance for Commercially Prepared Microbiological Culture Media*. The following microorganisms are routinely used for testing at Hardy Diagnostics:

#### **USER QUALITY CONTROL**

Users of dehydrated culture media should perform QC testing in accordance with applicable government regulatory agencies, and in compliance with accreditation requirements. Hardy Diagnostics recommends end users check for signs of contamination and deterioration and, if dictated by laboratory quality control procedures or regulation, perform quality control testing to demonstrate growth or a positive reaction and to demonstrate inhibition or a negative reaction, if applicable. Hardy Diagnostics quality control testing is documented on the certificate of analysis (CofA) available from Hardy Diagnostics Certificate of Analysis website. #### PHYSICAL APPEARANCE

CRITERION<sup>TM</sup> Sabouraud Dextrose Broth powder should appear homogeneous, free-flowing, and off-white in color. The prepared media should appear clear to slightly opalescent, and light amber in color.
